

- The article should be typed in Times New Roman, Font Size 12 and Line Spacing 1.5, justified.
- The footnotes must be typed in Times New Roman, Font Size 10 and Line Spacing 1( Footnotes are not mandatory).
- The margin in each side shall be 2.54 cm i.e. 1 inch.
- All submissions must follow the Harvard Bluebook system of citation 20th Edition.

#### Submission Guidelines

- The soft copy of the essay must be emailed to administrators one in Ms Word.doc/.docx format and one in PDF at <u>onlineunityessaycompetition@gmail.com</u> with the subject.
- "Justice Shah Muhammad Sulaiman National Essay Competition."
- The body of the e-mail must specify the Name, E-mail id, Contact number and name of the College/University along with the year and semester of the Participant.
- The essay should not contain names or any other marks which reveal the identity of the author.
